

Investment Comment & Outlook

Overall: Despite a sharp rally in October, equity markets remain vulnerable given the likelihood of disappointing policy action from the European authorities. Longer term, equities continue to be supported by reasonable valuations. Bond yields are expected to remain quite low.

Equity Markets

- Following two months of hefty declines, equity markets rallied strongly in October as investors reacted to hopes of a major resolution to Greece's debt crisis. Better economic data and good earnings' reports in the US also helped.
- World equities (in euro terms) rose by 6.5% during the month, leaving the total return for the first ten months of 2011 at -7%.
- Returns, in local currency terms, for the main markets in October ranged between 0% (Japan) and +13% (Hong Kong). Hong Kong had fallen 14% the previous month.
- In a mirror image of the previous month, cyclical sectors, such as materials, energy and industrials, outperformed defensive stocks. Financial stocks were mixed, performing well in the US, while European banks continued to underperform.

Commodities & Currencies

- Commodity prices rebounded sharply in October, after the collapse the previous month, aided by stronger economic data in the US and hopes that a resolution to the debt crisis in the eurozone would avoid a double-dip recession.
- Brent oil (European) ended the month up over 6% at \$110 per barrel, while West Texas (US) ended October up more than 17% at \$93 per barrel.
- The gold price regained exactly half of its September losses finishing the month up almost 7% at \$1,725 per troy ounce.
- The €/ \$ rate moved higher during the period, from 1.34 to 1.39, reversing part of September's move. The euro strengthened on the back of debt resolution hopes.

Bonds & Interest Rates

- After strong gains in recent months, eurozone bonds fell back by 3% in October. With the exception of France, which fell over 4%, the core once again outperformed the periphery.
- German 10-year bond yields rose from a multi-decade low of 1.6% to 2.0% at month end.
- Short-term eurozone interest rates have been increased twice during 2011 from 1% to 1.5%. However, markets now anticipate a volte-face from the ECB, with at least one rate cut expected by Christmas.
- The current market prediction is that UK and US rates will not be increased until the end of 2013.

Fund Allocations & Activity

Equities: The funds are underweight.

Bonds: The funds are close to neutral.

Activity: Equity positions were decreased towards the end of the period mainly in the US.

Regionally, the funds are:

- underweight in Ireland, Europe, the UK and Japan;
- neutral in the US and the Pacific Basin;
- overweight in no market.

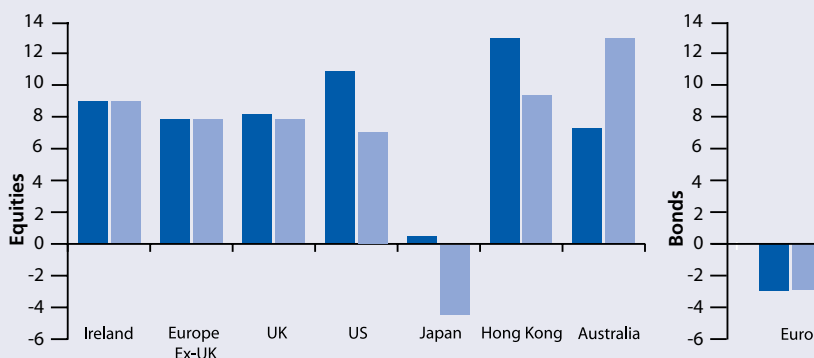
Sectorwise, the funds are:

- overweight technology;
- underweight financials and industrials;
- otherwise reasonably balanced.
