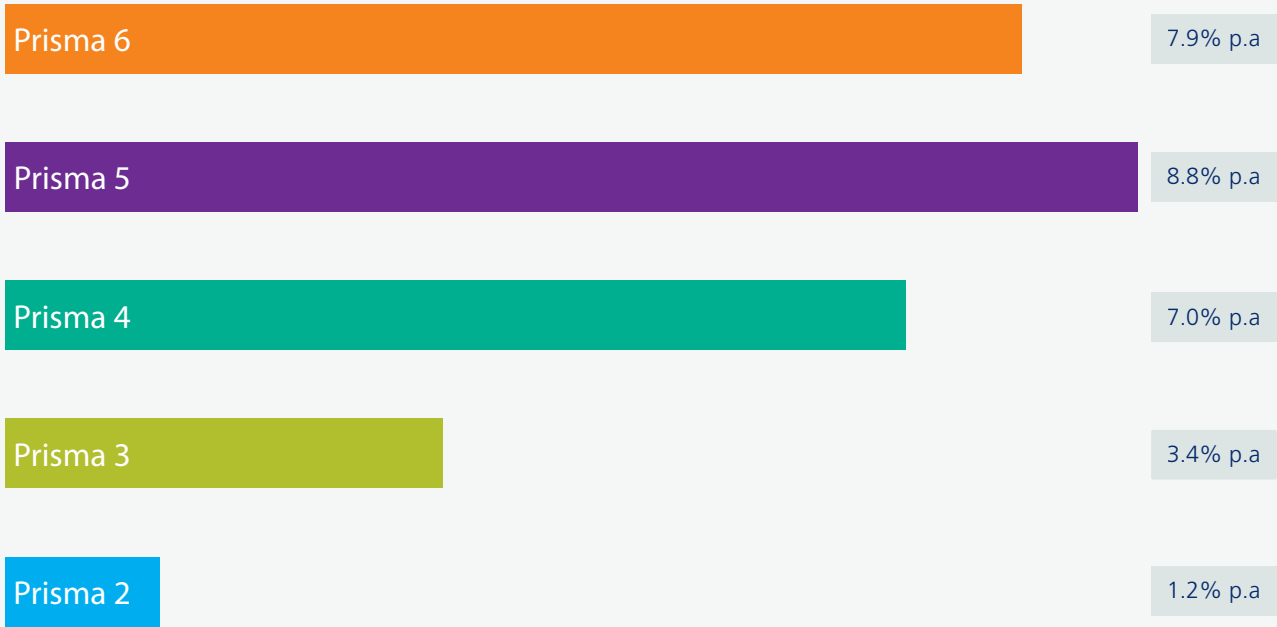

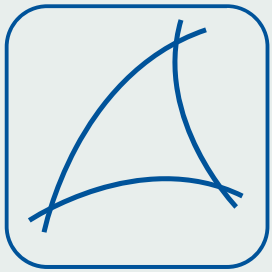
Celebrating five years of positive performance

Consistent positive annualised returns since launch



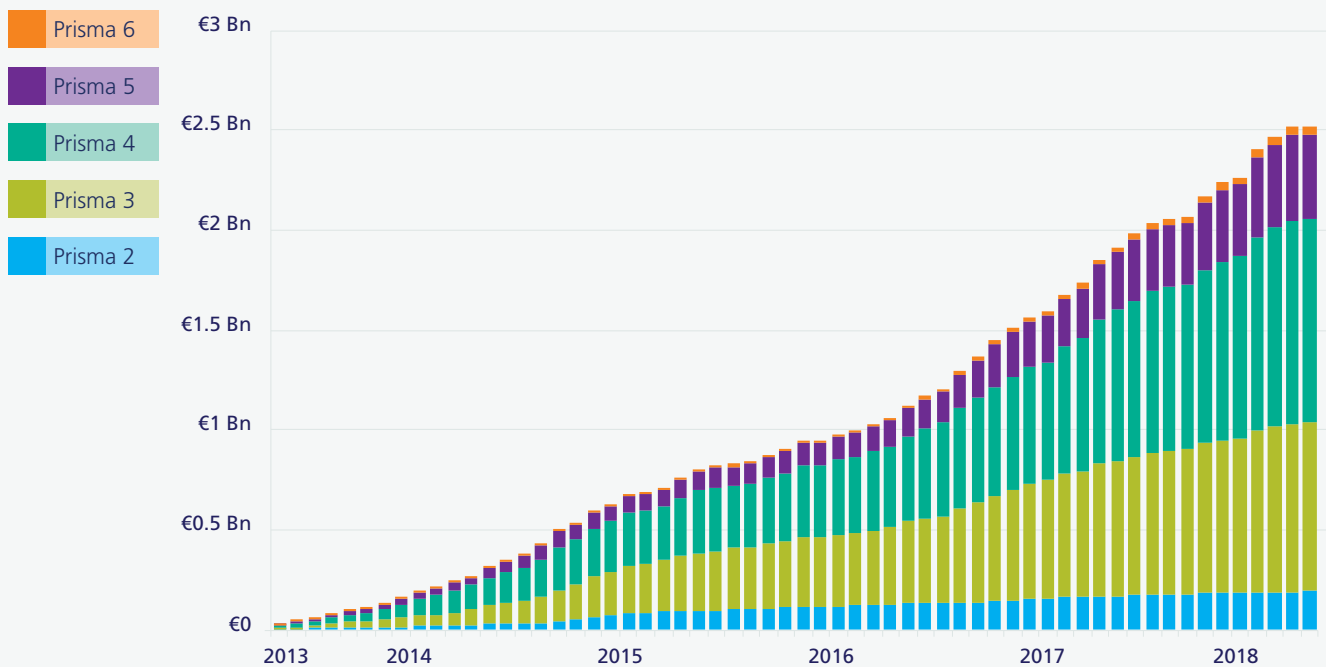

Stellar growth in assets under management



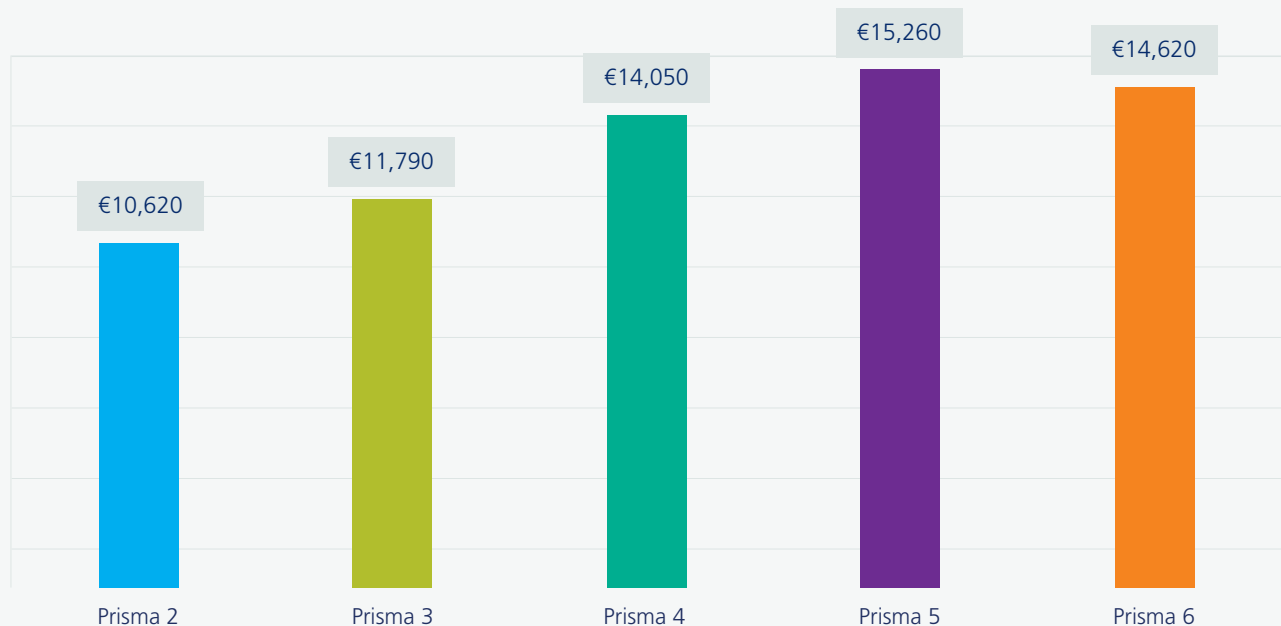

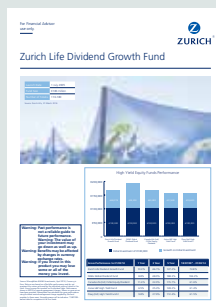
