Fund Description

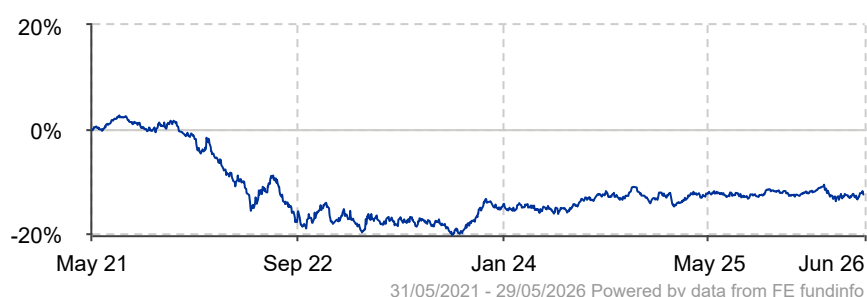

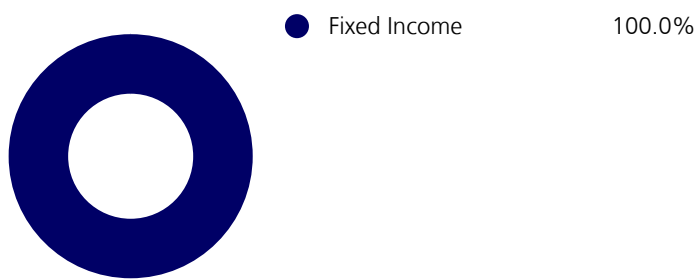

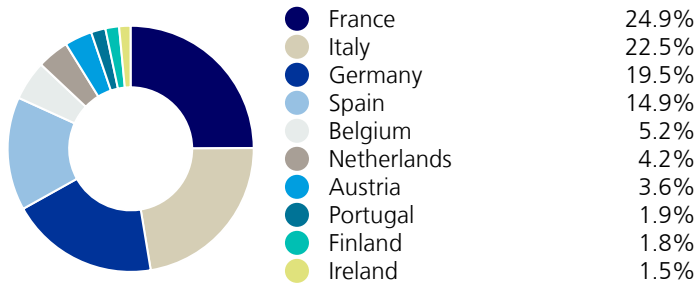
