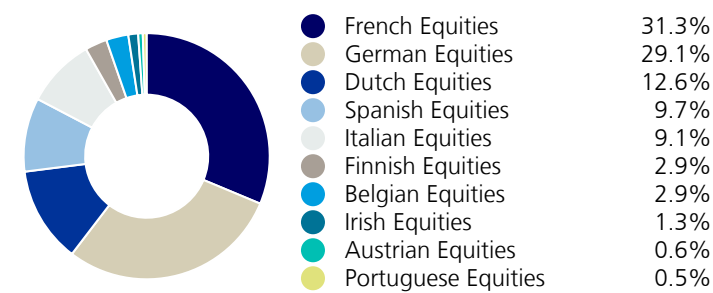

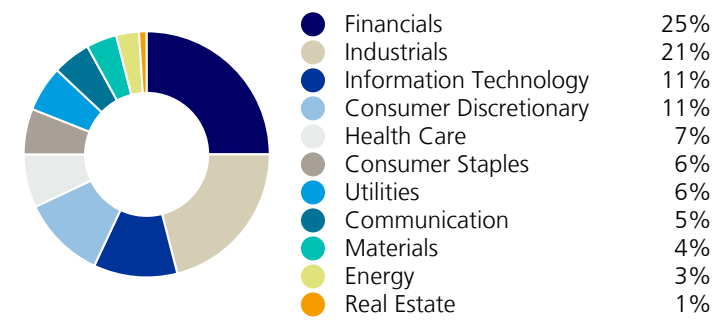
Asset Distribution (%)* as at 31/07/2025
