Fund Description

The Long Bond Fund invests mainly in longer-dated bonds with over ten years to maturity, primarily issued by eurozone governments. The fund is managed against a benchmark of the Merrill Lynch Eurozone Government Over 10 Years Bond Index. The minimum duration of the fund may not be less than 75% of the benchmark index duration. The managers may also invest in supranational bonds, other investment grade corporate and non-sovereign bonds and bond-based financial instruments. Corporate bonds are capped at a maximum of 10% of the fund. No more than 10% of the fund may be in non-eurozone bonds and then only the basis they are hedged back into the euro. This fund is managed by Eagle Star.

Investment Aim

The fund is managed against a benchmark of the Merrill Lynch Eurozone Government Over 10 Years Bond Index. Eagle Star will seek to add value to the fund and aim to out-perform the index by managing the duration of the portfolio and the mix of government and other investment grade securities.

Who should invest in the Fund?

Eagle Star has established the Long Bond Fund to provide pension scheme trustees with an appropriate match for mature or deferred pensioner liabilities.

Where pension liabilities require purchase of annuities, it is desirable that the pension assets are invested in matching instruments. Since the cost of purchasing annuities rises when interest rates fall, and vice versa, the appropriate matching asset is one which rises in value when interest rates fall. Long-dated bond prices are highly sensitive to interest rate movements and provide the best match for annuity based liabilities.

Typically, pensions in payment in Ireland have an average duration of 12 years and, with improved mortality, this is likely to lengthen. The benchmark index has a duration of 13 years and therefore the fund should provide an appropriate match for such liabilities.

The fund is also available as part of the Matrix range for both pension and investment clients. It can be used in conjunction with other funds to allow investors to build a diversified portfolio of investments.
