**New Regular Premium Applications with a Single Premium attaching/salary deducted PRSAs:** Please continue to use the regular online application process i.e. Completing and uploading the Personal Declaration as before.

# Signature Free OnlineApply for PRSAs

## Step 1 - You

Ensure you've got the following ready to input:

- Client details – see data capture form for details required.
- The correct email address and mobile number for your client.
- Transfer payment details (if applicable)

## Step 2 - You

Input client details

(For this step you could phone your client, chat with them face to face or ask the client to complete the data capture form prior).

Once submitted, the OnlineApply system will send the completed application to your client for approval.

## Step 3 - Your Client

The client receives an **email link** to the application form. For enhanced security a **validation code** will also be provided via text message to access the application form.

The client downloads the application. Once they're happy the details on the PDF are correct, all they need to do is confirm the declaration statement and **click "Approve Application"**.

## Step 4 - Zurich

Once the client approves, the application is automatically submitted to Zurich where it is processed.

If this policy is expecting a transfer payment from another life office - a 'Willing and Able' letter will be issued to the transferring life office as normal.

## Step 5 - Zurich

New

### Auto generated Willing and Able letters (For transfer payments).

Once your client approves the application form, the willing and able letter is automatically available in your pipeline under the correspondence tab.

If you would like to issue the willing and able letter to the transferring life office in addition to transfer request forms, feel free to download a copy of the willing and able here.

Your service team will also issue this willing and able when reviewing the application.

## Step 6 - You

When securely logged in to zurichbroker.ie, you'll see the application in your "previous applications" tab in the Sales section. Here you can;

- check the status of the application,
- edit the application, or
- resend the application to your client.

### Terms and Conditions

- Minimum premium €5,000 with a minimum term to Normal Retirement Age of 2 years.
