

Submitting applications to Zurich

Declaration upload, Signature Free or Offline. Find out below.



Most Zurich products can be submitted Online. Depending on the actual product, there are slightly different approaches.

- **Online:** Declaration upload – you can key the clients onto the Zurich system, and upload a copy of the clients signed declaration.
- **Online:** Signature Free – you can key the clients details onto the Zurich system, and the client will receive a link to review and approve the application without requiring a signature.
- **Offline:** There is no online journey currently available, so simply email the application to Zurich.
