We are pleased to announce the new release of our illustrations software (v7.01) for our pension, investment and savings products. The software is available for download to your system from today (for instructions, please see below).

## **New variations included in this release (effective from today, 27 January 2015)**

### **A(M)RF**

- We have enhanced our bonus allocation on the 103% gross allocation, 1% amc (plus trail) deals. For premiums  $\geq$  €100k we give a 1% bonus allocation.
- 101.5% gross allocation, 0.75% amc (inc. 0.25% trail) deals, *minimum premium €50k.*
- 101.5% gross allocation, 1% amc (inc. 0.50% trail) deals, *minimum premium €50k.*

### **Single Premium Pensions**

- Banded Single Premium Variations - 101% gross allocation, 0.75% amc (plus trail) deals. Premium related bonus allocations up to 103% gross allocation now available.
- 102% gross allocation, 0.50% amc (plus trail) deals, *minimum premium €100k. Client must be under age 55.*
- 101% gross allocation, 0.60% amc (inc. 0.20% trail) deals, *minimum premium €100k.*
- 101% gross allocation 0.80% amc (inc. 0.40% trail) deals, *minimum premium €100k.*

### **Personal Retirement / Buy-out Bonds**

- 102% gross allocation, 0.50% amc (plus trail) deals, *minimum premium €100k. Client must be under age 55.*
- 101% gross allocation 0.60% amc (inc. 0.20% trail) deals, *minimum premium €100k.*
- 101% gross allocation 0.80% amc (inc. 0.40% trail) deals, *minimum premium €100k.*
