The iShares Fund is passively managed and aims to track an index, but will not track it exactly.

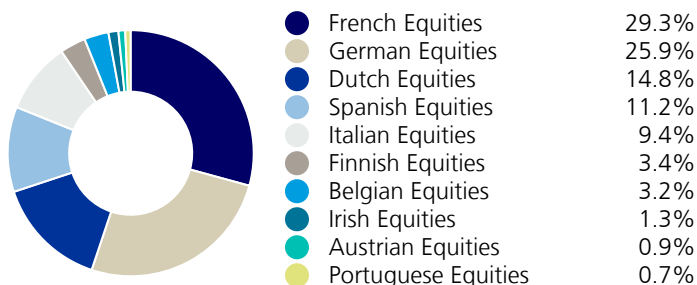

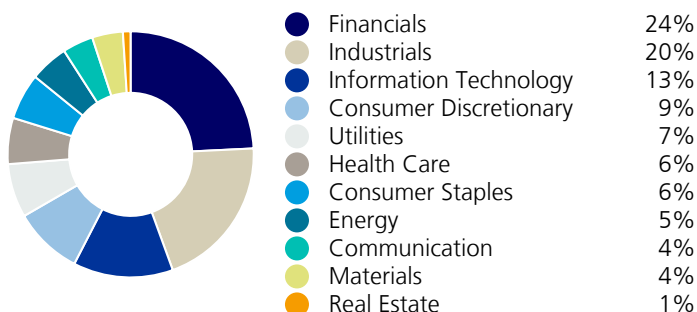
