
The UK Growth Fund (M&G) is a unit-linked fund that gives you the opportunity to participate in the performance of companies in the UK. To achieve this, it invests in the M&G UK Select Fund. The fund aims to achieve capital growth by investing at least 80% of its assets in a portfolio of shares in UK-listed companies with the emphasis on finding undervalued companies with attractive growth prospects. The fund may use financial derivative instruments for efficient portfolio management. As this fund invests most of its assets outside the eurozone, a currency risk arises for a euro investor. This fund is managed by M&G.

Yearly Investment Performance*


